That makes printer drivers and mappings, published application configurations and Presentation Server administration accounts all persistent data.

Incorrect options:

A: The Data Store holds persistent data and license files are not included. License files are kept on the MetaFrame Access Suite License Server.

B: User Profiles do not resort under persistent data. User profiles are kept locally on the MetaFrame Server - the default location is on the system drive of the MetaFrame Server under "Documents and Settings". User profile configurations can also be kept centrally on a file share as roaming profiles.

A: Executable files are programs - they do not contain settings.

C: [www.MyCitrix.com](http://www.MyCitrix.com) is used for managing Citrix licensing and has nothing to do with installation.

D: While MST files can be utilized to make selections for installs, it is not an answer file.

Answer: B

Explanation:

B: SSL Relay is the transport mechanism for secure communication between the Web Interface and the MetaFrame server. It encrypts information, ensuring that connection information can not be eavesdropped upon. Because the communications are secured using SSL/TLS, not only is the information encrypted, but message integrity checks exist that verify the data transmitted to ensure it has not been tampered with.

Incorrect options:

A. RC5 is a security protocol used in secureICA, which is used between clients and the MetaFrame Server.

C. The ICA protocol is used between clients and the MetaFrame Server for secure client connections.

D. Secure Gateway transparently encrypts and authenticates all user connections to protect against data tampering and theft. It does not operate between the Web Interface and the MetaFrame Presentation Server.

Incorrect options:

- A. This is not an option for client connection within the Program Neighborhood Agent install.
- B. A data collector is used to gather information about server load within a zone, and is not a static machine - a zone data collector is elected.
- D. This will provide security in communications, but does not provide the necessary information to make gather application information for pass through clients.

This was brought in to lower network utilization within large scale MetaFrame environments.

Incorrect options:

A: The zone data collectors are used to manage load - the data store contains static information about the MetaFrame Farm environment.

B: The zone data collectors are used to manage load - the data store contains static information about the MetaFrame Farm environment.

C: Starting with MetaFrame Presentation Server 3.0, load information is no longer shared with other zone data collectors within the farm.
