The single copy template enables developers to store design information in one template rather than in each database that uses the template, which results in less disk space used by the database. For instance, using the single copy template with a mail template stores all the design information in one place, making users' mail databases smaller because the databases no longer have to store the design as well as the data.

A is correct because the SCT must also be enabled through the Domino Administrator client. B, C, and D are incorrect because they are true statements about SCT.
